

## St. Joseph School Cash Card Tuition Credit Program Participant Agreement 2017-2018

St. Joseph School Scrip Program (referred to herein as “we,” “us” and “our”) is a fundraising program for the school which allows you to purchase Cash Cards for your everyday shopping needs. The cash cards you purchase through our program generates rebates from the participating retailers. A portion of these rebates can be used as a credit towards your 2017-18 Tuition Account (up to 30% of the family’s rebate with 70% going to the school), or 100% as a gift to the school. A minimum of \$10 tuition credit must be generated for a distribution to be made to a specific student’s account.

The parties agree to one of the following two options:

We agree to apply the balance of your rebates as designated below:

\_\_\_\_\_ Option 1: 30% of your yearly Cash Card rebates will be applied to your (or a designated) family’s tuition for 2017-18.

\_\_\_\_\_ Option 2: 100% of your Cash Card rebate will go to St. Joseph School fundraising fund.

Your participation in St. Joseph School Cash Cards Tuition Credit Program means you understand and agree to the following terms and conditions:

1. Cash Card rebates accrue from July 1, 2017 through June 30, 2018 and is distributed once in the Fall of 2018.
2. If your family is not returning in the Fall of 2017, your cut off rebate date will be April 15, 2017. The rebate value will be applied to the May/June 2017 tuition bill.
3. If you know you need to take this option, please initial here \_\_\_\_\_. Otherwise, it is your responsibility to notify the Scrip Coordinators of your family’s intention of not returning in the Fall 2017 by April 1, 2017, for your tuition credit distribution.
4. If you do not notify or leave within the 2016-17 school year, your family’s entire rebate will go to the school. These funds are not transferrable.
5. If a student/family leaves St. Joseph School during the academic year, tuition credits are forfeited and applied to the General Cash Cards’ Fund Account. Under no circumstances will Cash Card rebate credits be refundable.
6. If this contract is not returned, your family’s credit rebate will be submitted to the school.
7. NFS Checks or Presto Pay payments returned to St. Joseph School as Non-Sufficient Funds (NSF) will be charged, if your payment is returned for insufficient funds. Participating families will be responsible for payment of all charges related to such an occurrence.
8. We make no representations or warranties of any kind with respect to the Cash Cards. This agreement continues until June 30, 2017 or unless replaced by another, and can be terminated by either party upon 60 day’s advance notice to the other.

## Cash Cards Tuition Credit Program Enrollment Form 2017-2018

Please review the following items and return the completed form to the school office. This form must be completed and returned to enable your tuition credit for the school year of 2018-2019. If not returned, all rebates will be submitted to the school.

Cash Cards and certificates have a cash equivalency, and if lost or stolen cannot be replaced, traced, or refunded. I understand that once the Cash Cards' Envelope containing merchant certificates is placed into the Thursday Envelope/Backpack, it is considered in my possession. I assume all responsibility.
